- · Provide adequate information, training and supervision to enable all workers to work safely;
- Consult with employees in an open and respectful manner in all matters that affect their safety through established communication mechanisms to ensure an effective WHS performance is maintained;
- Conduct systematic audits to support compliance as a minimum with regulations and the Toward Zero Harm Framework;
- Provide injury Management and Rehabilitation services for injured employees that assist them in returning to pre-injury duties;
